The repair of damaged areas in wheel path, the preparation of CR 500 W and the placement of asphalt surface to CR 500 West from asphalt joint just south of Eucalyptus to River Rd..
(Approximately 9,556 SYS)

- Furnish labor and equipment to mill failed areas in the wheel paths in both Northbound and Southbound lane to an average depth of 4"
- Furnish labor and equipment to clean and prepare milled areas for the placement of asphalt base.
- Furnish labor and equipment to clean, edge, and Prep Street, preparing it for the placement of an asphalt overlay.
- Furnish, place, and compact #5D asphalt base to an average compacted depth of 4" to milled patches.
- Furnish labor and material to apply a tack coat at .08gal/sys to properly bond asphalt pavement.
- Furnish, place, and compact an asphalt surface wedge and leveling course to take assist in leveling the roadway for a better ride.
- Furnish, place, and compact #11/12 asphalt surface to an average compacted depth of 1½".

Price for the above construction\$116,300.00

Due to rapidly increasing liquid asphalt costs, our quotes will be valid for a period of 30 days. Executing this proposal within the 30 day time period allows E & B to secure firm pricing of liquid asphalt from our suppliers for this project. If we receive a signed proposal after the 30 day period, we may not be able to honor our pricing and our quotes will be adjusted accordingly.

Please note the following:

1. Indiana State Sales Taxes are not included in the above prices.
2. The above work is based upon being completed on weekdays and in the 2016 construction season.
3. All materials and workmanship will comply with the 2016 INDOT Specifications, Section 402.
4. Field engineering, testing, bonds or permits are not included unless otherwise noted.
5. Prime, herbicide, parking bumpers, sealcoating, & striping are not included unless noted.
6. Prices quoted are subject to existing drainage conditions.
7. A signed quote or contract is necessary before E & B Paving can begin work.
8. This quote may be withdrawn by E & B Paving if not accepted within 30 days.
9. An approved E&B paving, Inc. credit application is required prior to E&B Paving, Inc. performing any work.

A 1 ½ % percent monthly finance charge may be applied to all past due accounts. This computes to an annual rate of 18%. If any amount due for services or materials provided by E & B Paving, Inc. is not fully paid within 30 days from the date such services or materials were provided, it is agreed and understood that all costs and expenses including but not limited to attorney fees incurred by E & B Paving, Inc., relating to the collection of such amounts, will be recoverable by E & B Paving, Inc.
