## **SUPPLEMENTAL AGREEMENT NO. 1**

THIS SUPPLEMENTAL AGREEMENT, made and entered into this
day of, 2017, by and between Town of Yorktown, Indiana, acting by and
through the Town Council, hereinafter referred to as the "OWNER" and Butler, Fairman and
Seufert, Inc., Indianapolis, Indiana, Consulting Engineers, hereinafter referred to as the
"ENGINEER".

## WITNESSETH

WHEREAS, on May 22, 2017, the OWNER entered into an Agreement with the ENGINEER for services required for development of Contract Documents for the Nebo Road Sidewalk.

**WHEREAS**, Section 6, Changes in Work, of the General Provisions state that in the event of a substantial change in the scope, the maximum fee payable and the specified fee shall be adjusted, and

**WHEREAS**, a portion of the work to be performed under the original design scope, Appendix "A" will be amended to address the elimination of some right-of-way engineering services, and to add architectural services, and

**WHEREAS**, directed by the **OWNER**, the **ENGINEER** will provide the following amended engineering services as part of this Supplemental Agreement No. 1.

- 1. Delete right-of-way engineering services from the agreement; services will be limited to obtaining INDOT right-of-way certification and R/W staking for utilities
- 2. Develop schematic concepts for aesthetic treatments on the Nebo Road bridge

**WHEREAS**, the parties hereto agree that the **ENGINEER** shall cause to be made the amended work on an hourly not-to-exceed cost as follows:

Nebo Road Bridge Aesthetic Treatment Concepts \$7,500.00

TOTAL, HOURLY NOT TO EXCEED \$7,500.00

**WHEREAS**, the parties hereto agree that the **ENGINEER** will be paid for the Right-of-Way Engineering and Services performed under this Agreement in accordance with the following schedule:
