## REGULAR MEETING YORKTOWN PARK BOARD Field Operations Building May 24th, 2017

Meeting was called to order by Jon Myrick @ 5:30 pm.

## **OLD BUSINESS**

- BSU School of Architecture presented plans for a structure that they would design and build in the Lion's Club Park. Four plans were submitted, all to be built near the swings, slide, pavilion that are already in the park. There was a discussion among the members of the Arts Council and the Park Board members how challenging and safe the structure would be. The plan chosen was the first plan submitted, passing with a 5/0 vote by the members of the Park Board. Ball State University will provide \$2,500.00 toward the project, the Arts Council will donate \$500.00. Jon Myrick will donate time and material to drill all holes.
- BUTTERFLY habitat report: There are three Red Bud trees, three Butterfly bushes and about 58 flowering plants, including mild weed, to feed the larvae.

## **NEW BUSINESS:**

- CAR SHOW: the 40 & 8 American Legion is sponsoring a car show on July 30, 2017 in Morrow's Meadow. No admission charged, but each person showing an automobile will have an entry fee. Motion was made by Bob Drummond to allow this event to take place and was seconded by Peggy Flanagan. Motion passed.
- YOGA IN THE PARK: On Wednesday evenings from 5:30 until 6:30 there will be Yoga in the large pavilion during the months of June, July and August. Vicki Craig made a motion to allow this event to take place and was seconded by Greg Holzer. Motion passed.
