The Town does not have funds established for Rebar and Bison activities. The activity from those areas was provided from a separate ledger file. During the 2022 SBOA audit, the SBOA requested that the 2015, 2018, and 2019 lease rental bonds be transferred to the Yorktown Redevelopment Authority. All bond and interest, project construction, and related debt funds have been removed from this report for that purpose. The RDC has maintained the receipt of the tax increment finance revenues and recorded the lease rental payments as expenditures to the RDC.
