WHEREAS, the Town Council finds it appropriate to establish the Yorktown Department of Economic Development ("Department") and the Yorktown Economic Development Commission ("Commission");

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF Yorktown, INDIANA, PURSUANT TO THE ACT, THAT:

Section 1. The Department, controlled by the Commission, be and is hereby created and granted all powers and duties of such Department and such Commission as set forth in the act.
