

ORDINANCE NO. 794

An Ordinance to Amend Yorktown Ordinance No. 621 and Ordinance No. 671

BE IT ORDAINED BY THE YORKTOWN TOWN COUNCIL, TOWN OF YORKTOWN, INDIANA;

SEWAGE

That the Town of Yorktown, Indiana Ordinance No. 621 shall be amended as follows:

(1) Section 3a (1) and (2):

- (1) Treatment rate - Flow charge shall be \$5.82 per 1,000 gallons of usage for Phase I, effective July 1, 2020, and shall be \$6.69 per 1,000 gallons of usage for Phase II, effective January 1, 2021, plus
- (2) Base rate - as follows:

(2) Section 3b:

For users of the sewage works that are unmetered water users, the monthly charge shall be determined as an average monthly flow charge plus a base rate for a 5/8 inch meter:

(3) Section 3d:

Person Not Discharging Wastewater into the Sewage System

The owner of each and every lot, parcel of real estate or building that is connected, or is otherwise serviced, to the Town's sewage system, shall be subject to the payment of the sewage base rates presented in Section 3a (2) of this ordinance whether or not wastewater is being discharged from the property.

(4) Section 5a (1) and (2):

EXCESSIVE STRENGTH SURCHARGE

(1) Suspended Solids (in excess of 200 milligrams per liter of fluid)	0.36	0.41
(2) BOD (in excess of 200 milligrams per liter of fluid)	0.36	0.41

That the Town of Yorktown, Indiana Ordinance No. 671 shall be amended as follows:

PARK ONE INDUSTRIAL USERS

MONTHLY RATES

Total monthly charges: shall be the sum of the base service charges plus the treatment charges.
