RESOLUTION _____

WHEREAS, the Plan Commission of the Town of Yorktown ("Town") has considered the obligations of the contractor Berry Builders Incorporated to perform certain final road construction projects in the Wellington Knoll subdivision, as agreed upon by the Contractor; and

WHEREAS, Contractor has failed and refused to perform such projects; and

WHEREAS, the Town hereby elects to refuse to allow new construction in Wellington Knoll by lot parcels owned by Berry Builders (as of December 5, 2016 see attached map) until such projects are completed;

NOW, THEREFORE, BE IT RESOLVED that any and all new construction in Wellington Knoll on parcels owned by Berry Builder will not be permitted by the Town until such road construction projects are properly completed;

NOW BE IT FURTHER RESOLVED that notice shall be given to the contractor and to all owners of real estate in Wellington Knoll.
