To Whom It May Concern:

In the event that the Clerk Treasurer is temporarily unable to perform essential duties, the Deputy Clerk Treasurer, Amanda Reinke, the Town Manager, Pete Olson, and the Council President, Rich Lee, will be notified by email and by phone that the following procedures will begin.

Essential duties will be performed by Amanda Reinke including payroll, accounts payable, claims docket, paying taxes, sorting mail, creating council meeting minutes, and making daily bank deposits. Events that require a signature will be authorized through MutualBank/Northwest Bank and will be performed by Rich Lee and Amanda Reinke. Furthermore, Rich Lee will review and approve each check before signing. If the Clerk Treasurer and the Deputy Clerk Treasurer are unable to perform their duties, Erin Hurley, will be given access and authorization to take over essential duties of the office. If Rich Lee is unable to be a co-signer, then Robert Ratchford will be authorized in place of Rich Lee.

Additionally, Milo Sutton should reset the email password and provide a temporary password to access the email account of the Clerk Treasurer to whomever is performing the duties of the Clerk Treasurer. Donna Vinson of Hartman & Williams should be consulted to assist in assigning tasks, completing tasks, and overseeing the essential activities of the Clerk Treasurer's office. Monthly bank reconciliations should be completed by Donna Vinson in the event of a prolonged absence. After the Public Health Emergency and the temporary replacement of the Clerk Treasurer has concluded, Donna Vinson should be engaged to assist the Clerk Treasurer with reviewing and ensuring that all transactions were properly processed.
