SUBJECT: Lift Station 600 Controls Upgrade

The lift station 600 control system will be upgraded with new PLC hardware, operator interface, and radar level transmitter. The controls system will be programmed to provide fully automatic operation of pumps 1, 2 and 3 as well as mixer pump 4. All three pumps will be staged on & off base on the level of the wet well. All setpoints will be adjustable from the operator interface to configure the on/off levels for all pumps. Level status, pump status and alarms will be indicated on the operator interface. Automatic pump alternation will be available to give equal runtime on each of the pumps. Manual operation of the pumps can be done from the operator interface or from the operators mounted on the door of the enclosure. Lift station alarm status will be interconnected to the existing Omni-Site monitoring unit. Below is a list of services provided.
