Section 3.

As of 2024, all newly hired employees are responsible for 20% of group health insurance premiums, as well as all staff hired after 2012. All staff hired before 2012 are responsible for 10% of premiums. Additionally, starting January 2024 the Town will pay on behalf of all employees, the 3% employee share of the Indiana Public Employees Retirement Program (PERF).

Section 4.

This Ordinance shall be in full force and effect beginning the first pay in January 2025 following passage and adoption by the Yorktown Town Council. Section 5.
