ur source of supply, which is groundwater, comes from four wells completed in Silurian and Ordovician bedrock aquifers, containing carbonate limestone and dolomites. As water travels over the land or underground, it can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: microbes, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, livestock operations, and wildlife; inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; organic chemical contaminants, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban storm water runoff, and septic systems; pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm runoff, and residential uses; and radioactive contaminants, which can be naturallyoccurring or be the result of oil and gas production and mining activities certain minerals are radioactive and may emit forms of radiation known as photons and beta radiation. Some people who drink water containing beta particle and photon radioactivity in the excess of the MCL over many years may have an increased risk of getting cancer. Drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of these contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to substances found in drinking water than the general population. Immunocompromised persons such as people undergoing chemotherapy, people who have undergone organ transplants, people with HIV/ AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care provider.
