Individuals qualified for the Town of Yorktown health insurance shall be eligible to receive additional compensation in accordance with the performance of Employee Wellness Program goals.

Participation levels will be monitored by the Employee Wellness Committee and recommendations will be made to the Town Manager and Clerk/Treasurer according to the annual wellness plan.

## Section 3.

As of January 2012 all newly hired employees are responsible for 30% of group health insurance premiums. Additionally, employees hired after January 2012 are responsible for the 30% share of the Indiana Public Employees Retirement Program (PERF).
