## E & B Paving would like to submit price quotations & specifications for the following:

Phase 2 - The excavation for 8' walking/biking trail and the placement of stone and asphalt to 951' x 8' walk path. This trail runs from approximately the east property line of the church east 951'.

- > Furnish labor and equipment to excavate material to an average depth of 10.5" preparing the trail for the placement of stone and asphalt.
- > Furnish labor, equipment, and material to install drainage culvert under drive and re-grade existing side ditch.
- Furnish, place, and compact #53 stone to an average compacted depth of 6".
- > Furnish, place, and compact #5D asphalt base to an average compacted depth of 3".
- Furnish labor and material to apply a tack coat at .08 gal/sys to properly bond asphalt pavement.
- > Furnish, place, and compact #11/12 asphalt surface to an average compacted depth of 1.5".

## Price for the above construction .....\$79,615.00

\*\*If phases 2 is constructed while on site for phase 1 the total cost will be \$272,241.00. This is a savings of \$5,354.00.\*\*

Due to rapidly increasing liquid asphalt costs, our quotes will be valid for a period of 30 days. Executing this proposal within the 30 day time period allows E & B to secure firm pricing of liquid asphalt from our suppliers for this project. If we receive a signed proposal after the 30 day period, we may not be able to honor our pricing and our quotes will be adjusted accordingly.

## Please note the following:

- 1. Indiana State Sales Taxes are not included in the above prices.
- 2. E & B Paving requires a sufficient work area before mobilization. Additional mobes may require compensation.
- 3. The above work is based upon being completed on weekdays and in the 2017 construction season.
- 4. All materials and workmanship will comply with the 2012 INDOT Specifications, Section 402.
- 5. Field engineering, testing, bonds or permits are not included unless otherwise noted.
- 6. Prime, herbicide, parking bumpers, sealcoating, & striping are not included unless noted.
- 7. If the surface course is installed later, additional charges may be incurred for cleaning and prep work.
- 8. Prices guoted are subject to existing drainage conditions.
- 9. A signed guote or contract is necessary before E & B Paving can begin work.
- 10. This quote may be withdrawn by E & B Paving if not accepted within 30 days.
- 11. An approved E&B paving, Inc. credit application is required prior to E&B Paving, Inc. performing any work.

A 1  $\frac{1}{2}$  % percent monthly finance charge may be applied to all past due accounts. This computes to an annual rate of 18%. If any amount due for services or materials provided by E & B Paving, Inc. is not fully paid within 30 days from the date such services or materials were provided, it is agreed and understood that all costs and expenses including but not limited to attorney fees incurred by E & B Paving, Inc., relating to the collection of such amounts, will be recoverable by E & B Paving, Inc.
