E & B Paving would like to submit price quotations & specifications for the following:

Phase 1 – Place asphalt surface and seed along trail.

- Furnish labor and material to apply a tack coat at .08 gal/sys to properly bond asphalt pavement.
- Furnish, place, and compact #11/12 asphalt surface to an average compacted depth of 1½".
- Provide backfill and seeding along trail.

Price for the above construction\$20,096.00

Phase 2 – Excavation, place asphalt and seed along trail.

- Furnish labor and equipment to excavate material to an average depth of 10.5" preparing the trail for the placement of stone and asphalt.
- Furnish, place, and compact #53 stone to an average compacted depth of 12". (The 12" is due to the wet conditions in this portion of the trail.)
- Furnish, place, and compact #5D asphalt base to an average compacted depth of 3".
- Furnish labor and material to apply a tack coat at .08 gal/sys to properly bond asphalt pavement.
- Furnish, place, and compact #11/12 asphalt surface to an average compacted depth of 1.5".

Price for the above construction\$49,918.00

Phase 3 – Excavation, place asphalt and seed along trail.

- Furnish labor and equipment to excavate material to an average depth of 10.5" preparing the trail for the placement of stone and asphalt.
- Furnish, place, and compact #53 stone to an average compacted depth of 6".
- Furnish, place, and compact #5D asphalt base to an average compacted depth of 3".
- Furnish labor and material to apply a tack coat at .08 gal/sys to properly bond asphalt pavement.
- Furnish, place, and compact #11/12 asphalt surface to an average compacted depth of 1.5".

Price for the above construction\$69,867.00

** \$10,000.00 of the above Phase 3 price is an allowance to repair any irrigation lines. If it is not used it will go back to the Town. **

Due to rapidly increasing liquid asphalt costs, our quotes will be valid for a period of 30 days. Executing this proposal within the 30 day time period allows E & B to secure firm pricing of liquid asphalt from our suppliers for this project. If we receive a signed proposal after the 30 day period, we may not be able to honor our pricing and our quotes will be adjusted accordingly.

1. Indiana State Sales Taxes are not included in the above prices.
2. E & B Paving requires a sufficient work area before mobilization. 1 mobilization included. Additional mobilizations at no fault of E&B Paving, Inc. will be invoiced at \$1,500 each.
3. The above work is based upon being completed on weekdays and in the 2019 construction season.
4. Layout and staking by others. We require grade staking 50' on center, at all grade breaks and radius points.
5. All materials and workmanship will comply with the 2016 INDOT Specifications, Section 402.
6. A properly prepared and compacted subgrade to +/- 1" is required before our work can begin.
7. Field engineering, testing, bonds or permits are not included unless otherwise noted.
8. Prime, herbicide, parking bumpers, sealcoating, & striping are not included unless noted.
9. If the surface course is installed later, additional charges may be incurred for cleaning and prep work.
10. Prices quoted are subject to existing drainage conditions.
11. A signed quote or contract is necessary before E & B Paving can begin work.
12. This quote may be withdrawn by E & B Paving if not accepted within 30 days.
13. An approved E&B paving, Inc. credit application is required prior to E&B Paving, Inc. performing any work.
14. E&B Paving, Inc. cannot guarantee water surface drainage on areas of 1% slope or less.
15. Final invoicing to be based on field measurements or truck tonnage tickets.
16. Asphalt material will not be placed in ambient temperatures that are outside the parameters stated in the 2016 INDOT specs without 100% warranty sign-off prior to placement.

A 1 1/2 % percent monthly finance charge may be applied to all past due accounts. This computes to an annual rate of 18%. If any amount due for services or materials provided by E & B Paving, Inc. is not fully paid within 30 days from the date such services or materials were provided, it is agreed and understood that all costs and expenses including but not limited to attorney fees incurred by E & B Paving, Inc., relating to the collection of such amounts, will be recoverable by E & B Paving, Inc.
