AN ORDINANCE DECLARING AN ECONOMIC DEVELOPMENT TARGET AREA

7817 Logan Dr. Lot # 33 The Landings
(lot(s) or address) (subdivision or location)
in Yorktown, Indiana – Single Family Residence.
WHEREAS, the Indiana General Assembly has enacted a statute, I.C. 6-1.1-12.1 (the "Act"), authorizing certain deductions from the assessed value of new real proper improvements (as defined in the Act) for the purpose of allowing partial abatement of real esta property taxes attributable to redevelopment or rehabilitation in an area that is declared a economic development target area; and
WHEREAS, the Act provides that the Town Council or a Town may find that a particul area within the corporate limits of that town is an economic development target area after recommendation from an Economic Development Commission, and
WHEREAS, the Yorktown Town Council ("Council") has established standards at procedures for designation as an economic development target area by passage of Ordinance N 605, as amended; and
WHEREAS, the Yorktown Economic Development Commission has met in a publimeeting, reviewed the application and voted to recommend its approval.
NOW, THEREFORE, BE IT ORDAINED BY THE Town Council of the Town of Yorktow Indiana:
1. The Council finds and determines that the new single-family owner occupion residences to be constructed by the applicant on lot(s) # 33 7817 Logan Dr.
in <u>The Landings</u> in the town of Yorktow. Meet the qualifications for an economic development target area in accordance with the provisions of I.C. 6-1.1-12.1-7 and Local Ordinance No. 605, as amended.
2. The Town Clerk-Treasurer shall take such further actions as may be required by Ordinance No. 605, as amended, and other applicable ordinances and lows to carry out the

Purposes of this Ordinance to insure the eligibility of said new real property improvements for Purposes of this Ordinance to insure the eligibility of said new real property improvements for purposes of allowing a deduction from the assessed value of said improvements for three (3)

years.

- 3. This Ordinance shall be in full force and effect from and after its passage by the Council and after recommendation from the Yorktown Economic Development Commission, and such publications as may be required by law.
- 4. The Economic Development Target Area designation shall terminate after five (5) years from the date it is in full force and effect.
