


## **The Wall Memorial Visits Yorktown**

orrow's Meadow Park was the temporary home for the traveling war memorial referred to as "The Wall." This display, as well as exhibits from other wars, was available at the park in early October. The wall was an 80% replica of the Vietnam Wall Memorial in Washington, D.C. Other exhibits included more than 3.600 dog tags with names of service people who have been killed since Vietnam and names of the 9/11 victims.

## Field Operations to Relocate to Lions Club Park-



The Town of Yorktown is working to expand its field operations facilities. Current facilities are cramped and located in a flood plain. The Town purchased the Lions Club property late last year and intends to construct new facilities on those grounds.

Included in the development plans are new vehicle storage pole barn, salt storage building, and a new building with both offices and maintenance garage area. The office space will include areas for the Director of Field Operations and Director of Building, Planning and Zoning. There will also be office space for the Water, Street and Parks departments.

The cost to build the three buildings is estimated at \$550,000 and will take approximately six months to complete. It will be paid for out of the General Obligation bond approved earlier this year for this project and planned parks and recreation improvements. The existing Lions Club building will remain and will reopen for public use after construction at the site is complete.

## **Luminary Festival Set for Dec. 8**





# Yorktown Passes 2008 Budget

#### Town Tax Rate Expected to Drop

T n September, the Town of Yorktown adopted a new budget for 2008. rate the town has assessed in the last 6 years, came in 2002, the year While the budget, just over \$4.25 million, has grown by about 12% the state changed the way taxes were assessed. Even in that year, at 62 cents, Yorktown had the lowest tax rate of any incorporated city or L from last year, the town's tax rate has stayed stable because the town has experienced growth through annexation. #### **Proposed Sports Complex**

The town is getting closer to securing land for the proposed sports complex. Having received appraisals on the land, the Town hopes to have control of the land next month. Planned for the sports complex are additional baseball and softball diamonds as well as soccer fields. The town is seeking EDIT funding from Delaware County to offset some of the project costs.

A bond issue was approved by the Town Council last summer, partially for construction of the recreational facilities. Financial analysis conducted prior to the Town Council's decision indicated that sufficient room exists within current budgets to cover annual debt service payments without having to raise taxes for the project. While the Town's request for the bond issue received unanimous approval from the Local Government Tax Control Board, the Commissioner of the Department of Local Government Finance has delayed execution of the order because of unresolved property tax issues at the state and county level. The order is expected be signed within the next 30 days.
