## REGULAR MEETING YORKTOWN PARK BOARD Field Operations Building March 14, 2018

Meeting was called to order by Jon Myrick @ 5:30 pm.

Roll call: Park Board members present: Jon Myrick, Matt Reese, Laura Jaromin and Peggy Flanagan. Greg Holzer was not present. Pete Olson, Town Manager and Erin Hurley, Secretary were present.

The reading of the Minutes from January 2018 was presented, no corrections were made. The Minutes from the February 2018 was presented with the following corrections: at the Fireworks Festival there will not be a canoe race, no duck race and there will not be a carnival. Motion to accept the January Minutes as read and the February Minutes with corrections was made by Fete Olson and seconded by Laura Jaromin. Motion carried.

## **OLD BUSINESS**

- \* 11th Street property, located in Manor View Addition: An updated on 3/14/2018 plan for the area was given to the members of the park board. There will be an area for common plant plantings, additional soil has been purchased, plan to have a fund raiser to purchase pavers. Bricks from the Warner Gear/Borg Warner plant might be donated. Mulch, educational signage, birdbath (donated by a neighbor), Monarch Way Station and might need both versions of their butterfly habitat signs from the North American Butterfly Association. Perhaps have an Eagle Scout earn a badge by focusing on a pollinator garden. There were a few residents from the neighborhood present.
- \* Easter Egg Hunt in Morrow's Meadow on Saturday, March 31, 2018. There will be a pet parade at 11 a.m. The Easter Egg Hunt begins at noon. There are about 10,000 eggs to be found.
- \* Community Garage Sale will be in Morrow's Meadow on Saturday, May 19, 2018. Permit registration will be from April 23, 2018 until May 17, 2018. Vendors may set up between 6:30 a.m. and 7:45 a.m. The Sale hours are from 8 a.m. until noon. The fee for a 10' X 20' space is \$5.00. Multiple spaces may be purchased. The Garage Sale will be held rain or shine. Cancellations must be made by Tuesday, May 15, 2018 at 4 p.m.. You must be 18 or older to purchase a space and sell. An identification may be required. No vehicular traffic in the park from 7:45 a.m. until 12:10 p.m. Items NOT permitted for sale include: guns, knives, any kind of weaponry, alcoholic beverages or products of any kind, pornographic materials of any kind. If you are vending food products you, the vendor, must retain any permits from the Delaware County Board of Health.
- \* Fireworks Festival: There will be a duck tape and cardboard boat race midday. There will be a DJ during the evening hours. Fireworks will begin at dusk, which is about 9:30-10 p.m. There will be food vendors in the park.

## **NEW BUSINESS**

\* Mary Ann Stroeh requested a fee wavier for the large pavilion on Mondays from

June 4, 2018 until July 30, 2018 for Kids in the Meadow program. The week of July 4th will not have a program for the Kids in the Meadow. Laura Jaromin made a motion to allow this venture and was seconded by Matt Reece. Motion carried.

\* The 11th Street Project: The people have set the first set of bricks. The town will install a water spigot but the residents of the area will need to monitor it so it will not be left running when not needed. The Town of Yorktown will continue to mow the grass as of now, this may need to re-visited as the plans for the area come to fruition and the area will me more difficult to mow.

Motion to adjourn was made by Peggy Flanagan and seconded by Laura Jaromin. Motion carried. Meeting adjourned at 6:05 pm.
