American Legion Bridge Painting

The American Legion post has requested permission from the Town to repaint the footbridge behind Pizza King that connects to their property. They submitted an artist's rendering of the design. Pete Olson would like the Park Board to consider the proposal. After discussion the members stated that as long as the appropriate paint is used and the American Legion members will maintain it, that it would be an asset to downtown. They don't want chipping and the old green paint showing through.

Greg Holzer made a motion to allow the American Legion to repaint the bridge with the design submitted. Second by Laura Jaromin. All members present voted Aye.
